1. Who are the present members of the Allestree Board and when was the present board formed?	This year's membership hasn't been agreed. Applications for renewal to stay on the board have been sent out and responses currently being collated.
2. How many times have they held meetings and what were the dates of the meetings?	Three times a year. For 23/24, the dates were: 28/09/23 14/11/23 29/01/24
3 Where and when do you report on these meeting that are made known to Allestree Residents?	The Neighbourhood Board is a closed meeting. Committee meeting minutes are published on CMIS.
4. I understand that the members of the board as a group decide which applications are agreed and funded. Presumably this is by a vote from all members in attendance, is that correct?	The board members are present in advisory capacity. Ward Councillors make the decision around which applications are funded.
5 What projects have been granted funding by the present board and how much has been allocated to each?	Tree shredding for Christmas trees - £350 Christmas trees - £90 for three. Installation, removal and shredding - £103.80 Allestree Bowls Club - £1500 for pathway and boiler Woodlands FC - £1265 towards kit for a new team.

6. How much funding is still available?	No funding has been agreed out of the 24/25 budget currently. There was a carry over of £151.73 from the 23/34 budget (awaiting final confirmation of this figure from Finance).

8. How do you check that the funding is actually spent on the project the money was requested for?	We send out monitoring forms with the award letter, which they have 3 months to complete and return.
9. Can members of the public attend (but have no input) to the Board meetings?	No – this is not a public meeting.

10. What dates are the meetings held and how much notice do members receive?	Meetings have not yet been arranged for 24/25 as we are awaiting the meetings calendar from Democratic Services, which will happen after the Councils AGM. Board members are given at least 7 days notice.
