Act 1972 and every other power hereunto enabling, **WE**, the DERBY CITY COUNCIL, acting as the Burial Authority for the CITY OF DERBY, and acting by Angela Nex, Proper Officer, in consideration of the sum of two hundred & sixty six pounds fifty pence to us paid by [REDACTED]

(hereinafter called the 'Grantee') **DO HEREBY GRANT** unto the Grantee and her heirs and such of his or their assigns as the said Council shall approve the exclusive right of burial for a period of 100 years from the date hereof in Grave Space numbered E.83 on the plan of the Cemetery known as Chellaston CEMETERY DERBY in ~~consecrated~~^{general} ground, being part of the Burial Grounds provided by the said Council to a depth not exceeding nine feet **TO HOLD** the same unto the Grantee her heirs and assigns for the purpose of Burial only subject to the fees and charges now in force or which may hereafter be made from time to time with regard to interments by the Council and subject to such restrictions and regulations now in force or which may hereafter be made for the management, regulation and control of the said Cemetery by order of the Secretary of State.

AND it is hereby certified that the transaction hereby effected does not form part of a larger transaction or of a series of transactions in respect of which the amount or value or the aggregate amount or value of the consideration exceeds twenty-five thousand pounds.
