At the time of my visit, I spoke with yourself. During my visit I completed a full food hygiene inspection and considered the specific areas that you told me had been improved since the visit I carried out on 10 October 2024.

Should you or the brewery decide to have a mobile trader vending from the car park you must ensure that the trader is a registered food business and that they have relevant street traders license consent. I remind you that it is your responsibility to ensure that your business complies with all relevant legal requirements on an ongoing basis.
